

The International Commission on Glass (ICG) was successful in achieving the year 2022 named as the International Year of Glass 2022. The ICG will now develop a structure to ensure the industry benefits from this once in a lifetime opportunity for the glass industry worldwide.

Page | 1 **United Nations Resolution L84 (Extract)**

Recognizing that glass has accompanied humankind for centuries, enriching the quality of life of millions, and one of the most important, versatile and transformative materials of history, glass is an important component in many areas, including in aerospace, the automotive sector, architecture, the arts, information and communications technology, energy, health care, laboratory work, optics and packaging and storage.

The International Year of Glass, 2022 will underline the technological, scientific, economic, environmental, historical and artistic role of glass in our societies, emphasising the rich possibilities of developing technologies and their potential contribution to meeting the challenges of sustainable development and inclusive societies, achieving world economic recovery and building back better from the coronavirus disease (COVID-19), bring together the threads of technology, social history and art through educational programmes and museum exhibitions.

ICG Coordinating structure

To manage this once in a lifetime opportunity the ICG will develop a structure to include input and activities from all regions of the world and across all sectors that glass is a component part.

Level 1

IYOG Council

Includes representatives of major countries supporting IYOG2022. It will consist of 60 plus members to discuss and decide on activities, events and general policy of IYOG2022. The members of this Council will act as the link with the national RO's or structures organised by the different countries to develop IYOG. The major aim is to share all the activities (using the IYOG website) disseminating and coordinating activities and events around the world.

IYOG Executive Committee (ExCo)

Selected from the IYOG Council, with a smaller number (8-10) of members. Responsible for deciding major events and ensuring and coordinating the resolutions outcomes for the IYOG 2022 are achieved. The ExCo will work with Regional Organisations who will have responsibilities to promote IYOG2022 in that region. The ExCo will report to the Council on progress, opportunities and activities on an agreed time frame.

Level 2

Multiple Regional Organisations (RO)

Developed by the Council/ExCo these RO's will be responsible for developing working groups and their activities. The RO will coordinate activities and promotions across the nominated

region, i.e., Oceania, North America etc. and report to the ExCo all activities in that region.

Level 3

Sector specific working groups (WG)

Each RO will develop working groups to cover all the sectors active within that region such as glass recycling, scientific, artistic, glazing, glass blowing, hollow glass, etc. Each WG will be responsible for activities within the allocated sector and report to the RO on an agreed timetable.

Nomination for a Regional Organisation membership.

RO's and the WG's will be the drivers of the IYOG2022. It is therefore important that Expression of Interest nominations bring a wide range of skills, networking contacts or knowledge of the sector they nominate for. Nominations can only be made on the form attached. Once completed it should be returned to the email address shown.

Data management and privacy.

All information supplied will be dealt with under the requirements of the relevant Privacy, Data Protection, and anti-spam legislation within the region of operation.

Nomination for a regional organisations committee and working groups

1. Expressions of Interest (Eoi) can be from individuals, businesses, associations or organisations.
2. Eoi's are for either work group committee nominee and/or as a workgroup member.
3. Membership of the ICG regional committee for the IYOG2022 will require members to focus on their area of expertise whilst supporting the ICG regional committee's holistic activities across all sectors of glass related industries.
4. Meetings will be monthly via online meetings wherever possible
5. Applicants are to read and accept the Code of Conduct by ticking the box in the Expression of Interest form.

Code of Conduct

Preamble

This Code of Conduct has been developed by the International Commission on Glass for participants in the International Year of Glass 2022 project. This includes Committee members, workgroup members, individuals and organisations.

Introduction

The IYOG2022 Code of Conduct is designed to act as a reference point for all participants using the IYOG2022 logo, persons involved in official or semi-official capacity or involved in activities that are based on the IYOG2022 concept. Compliance with this Code will foster and maintain public trust and confidence in the integrity of the IYOG2022 project. This IYOG2022 Code of Conduct is a guideline of the *minimum set of expectations* that all participants in any IYOG2022 activity will ensure they comply to.

Principles and Values

All participants in any IYOG2022 activity are expected to:

- Act with the goal of fostering a sustainable and thriving glass industry.
- Act at all times with honesty, integrity and responsibility.
- Promote fair and equitable dealings with others.
- Encourage and preserve skills in the industry sector they operate in
- Act in a manner which advances the standing of the glass industry in the community.
- Avoid all conduct likely to bring the glass industry or International Commission on Glass, and partners associations, into disrepute

Rules of Behaviour

All participants in any IYOG2022 activity will:

- Comply with the IYOG 2022 Code of Conduct.
- Comply with all relevant standards or laws in all projects/activities developed
- Provide a safe working environment for all participants in any IYOG2022 activity
- Assist others in developing IYOG2022 when appropriate and not in conflict with their own requirements
- Observe the intent of the relevant laws of the jurisdiction they are operating in including, but not limited to, email telecommunication and anti-spam laws. collusion or anticompetitive behaviour, passing off, intimidation, bribery in all its forms and fraudulent practices.
- Understand and actively comply with work, health and safety principles and relevant legislation of the jurisdiction they are operating in
- Avoid real or perceived conflicts of interest whenever possible, and disclose them to affected parties when they do exist.
- Inform the International Commission on Glass about any known breach of the IYOG 2022 Code of Conduct as soon as possible.
