A proprietary system supplier designs, owns, and supplies window, door, and glazing systems built around proprietary designs, components, and specifications that are licensed for use by the manufacturer network.

2. Window Manufacturers/Suppliers Applicants:

A window manufacturer produces complete window and door units by fabricating and assembling frames, glazing, and hardware to meet specific performance, design, and regulatory requirements.

A window supplier sources and provides finished window products to builders, contractors, or retailers without necessarily manufacturing them.

The products may be used for either residential or commercial work

4. Window Installation/Service/Repair Applicants:

Window installation, service, and repair in New Zealand covers the compliant fitting of new windows and doors, routine maintenance and adjustments, and the repair or replacement of windows and doors and/or damaged components to ensure weather-tightness, safety, and ongoing compliance with the NZ Building Code.

5. Glass Processing & Glazing Applicants:

A glass processor transforms raw flat glass into finished or semi-finished products, such as, annealed, toughened, laminated, and/or coated glass either monolithic or processed into IGU's, ready for use in windows, façades, and other applications.

A glazier measures, cuts, installs, and replaces glass in windows, doors, façades, and other building elements.
